Located in Northern California, Eureka is the largest city in the County of Humboldt with approximately 50,000 residents including the unincorporated area. Eureka is one of California's best kept secrets, bordered by the beautiful Humboldt Bay and forests lush with giant redwoods. A variety of cultural opportunities are available in and around the city. # OUR DEPARTMENT

Responding to approximately 7,400 calls for service each year (from 5 Fire Stations), HBF is a full-service, all-risk fire department. In terms of critical infrastructure, HBF is the emergency service provider for a number of high-hazard occupancies, including various types of building construction ranging from old Victorian residences to modern commercial occupancies; 1 municipal airport; 1 hospital; 1 fuel distribution bulk storage plant; as well as a large area in the "Wildland Urban Interface" in the outlying areas of the jurisdiction.



HBF's staff and firefighters are highly motivated and trained to deliver the best possible community service locally, throughout Humboldt County, and throughout the state of California. From fire and rescue services, to our delivery of Emergency Medical Services, to general public service we stand ready to help 24 hours a day, seven days a week.

# THE IDEAL CANDIDATE

Humboldt Bay Fire seeks individuals whose values align with our departments mission of being committed to community service through leadership, vision and integrity.

Our firefighters take pride in their work as their position protects life, property, and the environment by performing firefighting activities, emergency medical aids, hazardous response, rescues, fire prevention, and other emergency and non-emergency situations. The position is also responsible for maintaining fire equipment, apparatus and facilities.

The ideal candidate for Humboldt Bay Fire is a professional with a desire for a fire service career, emphasizing in teamwork and cooperation. They should bring life experience fostering honesty and a strong work ethic, and exhibit positive engagement in diverse professional settings. Crucial attributes include technical proficiency, a genuine interest in teaching, and an attitude promoting a positive fire service image. Demonstrated readiness for emergency service, effective communication skills, a comprehensive fire service education, commitment to high physical fitness levels, and proven customer service experience are essential. Moreover, the ideal candidate should actively seek opportunities to enhance and improve Humboldt Bay Fire.

The culture instilled by our personnel is recognized as a significant factor in creating the Humboldt Bay Fire's reputation as an excellent workplace. We place a strong emphasis on physical fitness, training, health, and overall wellness. Additionally, there is a palpable enthusiasm for the education and mastery of the skills associated with firefighting and emergency medicine.

# MINIMUM QUALIFICATIONS

- 18 years of age
- High School Diploma, GED or any combination of training and experience that would provide the required knowledge, skills and abilities is qualifying.
- Pass the Firefighter Candidate Testing Center (FCTC) Entry Level Firefighter Written Exam and be placed on the FCTC Statewide Eligibility List by time of interview
- Possess a current, valid Cal-JAC CPAT Card
- Possess a valid California Firefighter 1 certificate or complete an accredited fire academy
- Possess a current, valid California or National Registry EMT-1 or Paramedic certification (note: persons possessing a National Registry Certification will be required to register as a California EMT-1 or Paramedic prior to appointment).
- Possess a valid California Class "C" Driver's License with a clean driving record.



## **In addition to the above, employees are required to obtain within the twelve (12) month probationary period:**

- Valid California driver's license firefighter endorsement
- CDL Medical Examiners Certificate
- Hazardous Materials First Responder Operations Certificate (FRO)
- Hazardous Materials First Responder Operations Decontamination Certificate (Decon)
- California State Fire Training Rope Rescue, Confined Space Ops. and RS-1 or equivalent

# SCHEDULE

Employees are required to work 24-hour shifts as scheduled by HBF currently in a "48-96" model. Humboldt Bay Fire has no residency requirement but employees are subject to emergency recall.

**A complete application packet shall include an application form and supplemental questionnaire, a copy of current CPAT card, a copy of California Firefighter 1 certificate or certificate of completion from an accredited fire academy, a copy of current EMT-1 or Paramedic certificate and a copy of a valid California Class "C" Driver's License.**

## **EXAMINATION PROCESS**

We will not be conducting our own internal written or physical agility test. Candidates must be on the FCTC statewide eligibility list to be eligible. The top candidates selected from the application process will be invited to an oral board examination. The top candidates from the oral board examination will be invited to participate in a Chief's Interview to establish an eligibility list.

**Holiday Pay:** In lieu of Holiday time off, 192 hours shall be paid annually at the regular rate of pay.

**Uniform Allowance:** \$480 annual payment

**ADDITIONAL INCENTIVES INCLUDE ACCRUING UP TO 144 HOURS OF CTO.**

**RETIREMENT:** 2% at age 50 retirement formula for Classic CalPERS members; or 2.7% at age 57 based on provision of the California Public Employees Pension Reform Act of 2013 (PEPRA).

**HEALTH INSURANCE:** HBF covers 80% of medical premium for the employee and eligible dependents and contributes to each employee's Health Savings Account. Cash-in-lieu available if employee has medical from another source.

**DENTAL & VISION INSURANCE:** HBF covers 100% of dental, vision and EAP premiums for employee and eligible dependents.

**OTHER BENEFITS:** Annual health and wellness assessment. Optional participation in deferred compensation and Section 125 plans including Flexible Spending Accounts.



**VACATION:** Vacation is accumulated at 7 shifts per year upon employment and increases with time in service. Vacation buyback is available.

**SICK LEAVE:** Sick Leave is accrued at one 24-hour shift per month with no limit. Sick leave conversion to service credit is available at time of retirement through CalPERS.

**OTHER INSURANCE:** HBF provides a robust EAP program, Group Life Insurance for all employees and AirMED coverage for employees and all members of their household.
